But too many young children don't get a chance to build the fundamental brain architecture that allows them to thrive in school and in life. In 2019, Children's Alliance supported efforts to increase the reimbursement rate for Working Connection Child Care and expand access to the state funded preschool program, as well as keeping focus on longer term efforts to address barriers to high quality care, while preserving and expanding the diversity of the child care workforce.

4b (Code:) (Expenses \$ 375,144. including grants of \$) (Revenue \$) In 2019, Children's Alliance continued its work in public policy advocacy and implementation advocacy for programs that support healthy children and families. The organization continued its work to expand access to dental care in multiple ways, supported the advocacy of Pacific Islander communities for access to dental care programs, and expanded engagement in infant and maternal health in its community.

4c (Code:) (Expenses \$ 245,268. including grants of \$) (Revenue \$) Children's Alliance is the Annie E Casey Foundation Kids Count grantee in Washington State. In collaboration with the Washington State Budget & Policy Center, this work develops and promotes dissemination and understanding of critical data necessary to understand the state of Washington's children, and develop effective policy solutions.
